Sewer Construction Update

Chatham – C.C. Construction, Inc. will be continuing work for the Phase 1D-2A: Route 137 – Morton Road Sewer Extension Project (1D-2A) and for the Queen Anne Pumping Station (QAPS) Upgrade as outlined below. Dig It Construction LLC will be continuing work on the Phase 1E-2 – Stage Harbor Road Sewer Extension Project (1E-2).

Work for the week of February 12th – February 16th:

1D-2A:

- Continued site work at Pump Station #3 (Meetinghouse Road) and Pump Station #4 (Twine Field Drive) is expected.

QAPS:

- Site work at pump station site (40 Queen Anne Road; south side of Queen Anne Road and Oyster Pond Furlong intersection).

1E-2:

- Continued dewatering expected at the pumping station site (Old Mill Boat Yard/Harbormasters Garage) and along Stage Harbor Road.
- Commence directional drilling of pressure sewer on Atwood Lane, Honeysuckle Lane, and Cedar Swamp Lane (North and South). The estimated schedule is as follows:
 - Monday 2/12 and Tuesday 2/13 – Atwood Lane
 - Wednesday 2/14 and Thursday 2/15 – Honeysuckle Lane
 - Friday 2/16 – Cedar Swamp Lane

For public safety reasons, the road will be closed from Honeysuckle Lane to Bridge Street. Local traffic only but access may be limited depending on the construction. Police details and signage will be in place. The detour will be as follows:

- ***Detour from Champlain Road – via Bridge Street***
- ***Detour from Bridge Street around Champlain Road***
- ***From Stage Harbor Road – via Cedar Street to Champlain Road***
- ***Additional details are provided in the figures below.***

Two Week Look Ahead (2/19 – 2/23):

1D-2A:

- Continued site work at Pump Station #3 (Meetinghouse Road) and Pump Station #4 (Twine Field Drive) is expected.

QAPS:

- Site work at pump station site (40 Queen Anne Road; south side of Queen Anne Road and Oyster Pond Furlong intersection).

1E-2:

- Continued dewatering expected at the pumping station site (Old Mill Boat Yard/Harbormasters Garage) and along Stage Harbor Road.
- Continued directional drilling of pressure sewer on Cedar Swamp Lane (North and South). The estimated schedule is as follows:
 - Monday 2/19 – Cedar Swamp Lane
 - ***Traffic impacts expected – updates will be provided in a subsequent press release. A similar detour as shown the prior week expected.***

Three Week Look Ahead (2/26 – 3/1):

1D-2A:

- Continued site work at Pump Station #3 (Meetinghouse Road) and Pump Station #4 (Twine Field Drive) is expected.
- Sewer work expected at the Chatham Water Pollution Control Facility (WPCF).

QAPS:

- Site work at pump station site (40 Queen Anne Road; south side of Queen Anne Road and Oyster Pond Furlong intersection).

1E-2:

- Site work expected at the pumping station site (Old Mill Boat Yard/Harbormasters Garage) and along Stage Harbor Road.

Please note that this is a projected schedule and will be adjusted accordingly based on the Contractor's actual progress and the weather.

Roads will be passable at the end of each day. Police Details and Contractors will work with residents to ensure their needs for access are addressed.

Police Details and signage will be in-place to assist motorists in reaching their destination.

Normal work hours are 7:00 AM to 4:00 PM Monday to Friday, weather permitting, unless otherwise noted.
