### **Sewer Construction Update**

Chatham – C.C. Construction, Inc. will be continuing work for the Phase 1C-5 – Oyster Pond Sewer Extension (1C-5), Dig It Construction LLC will be continuing work on the Phase 1E-2 – Stage Harbor Road Sewer Extension Project (1E-2), and Robert B. Our Co., Inc. will be continuing work on the Mill Pond Pumping Station Upgrade (MPPS) as outlined below.

#### **Work for the week of January 20<sup>th</sup> – January 24<sup>th</sup>:**

##### **1C-5:**

- Continued sewer and water work on Pond View Lane (West). **Local traffic only, detour will be in place. Police detail(s) will be on-site and signage in place to assist residents.**
- Continued site work is expected at the Oyster Pond Condominiums pumping station site (1233 Main Street).

##### **1E-2:**

- Continued site work is expected at the pumping station site (Old Mill Boat Yard/Harbormasters Garage).

##### **MPPS:**
