### **Sewer Construction Update**

Chatham – C.C. Construction, Inc. will be continuing work for the Phase 1C-5 – Oyster Pond Sewer Extension (1C-5), Dig It Construction LLC will be continuing work on the Phase 1E-2 – Stage Harbor Road Sewer Extension Project (1E-2), and Robert B. Our Co., Inc. will be continuing work on the Mill Pond Pumping Station Upgrade (MPPS) as outlined below.

#### **Work for the week of June 2<sup>nd</sup> – June 6<sup>th</sup>:**

##### **1C-5:**

- Continued sewer and water work is planned on Kelley Lane. **Local traffic only. Police detail(s) will be on-site and signage in place to assist residents.**

##### **1E-2:**

- Continued site work is planned at the pumping station site (Old Mill Boat Yard/Harbormasters Garage).

##### **MPPS:**

- Continued site work is planned at the Mill Pond pumping station site (85 Mill Pond Road).

#### **Two Week Look Ahead (6/9 – 6/13):**

##### **1C-5:**

- Thursday 6/12 and Friday 6/13: Pavement preparation and paving is planned on Kelley Lane and Pond View Lane. **Local traffic only. Police detail(s) will be on-site and signage in place to assist residents.**
- Sewer work is planned to begin on Smith Street at the intersection with Vineyard Avenue. **Local traffic only, detour will be in place. Police detail(s) will be on-site and signage in place to assist residents.**

**1E-2:**

- Continued site work is planned at the pumping station site (Old Mill Boat Yard/Harbormasters Garage).

**MPPS:**

- Continued site work is planned at the Mill Pond pumping station site (85 Mill Pond Road).

**Three Week Look Ahead (6/16 – 6/20):**

**1C-5:**

- Continued sewer work is planned on Smith Street. *Local traffic only, detour will be in place. Police detail(s) will be on-site and signage in place to assist residents.*

**1E-2:**

- Continued site work is planned at the pumping station site (Old Mill Boat Yard/Harbormasters Garage).

**MPPS:**

- No work planned.

Please note that this is a projected schedule and will be adjusted accordingly based on the Contractor's actual progress and the weather.

Roads will be passable at the end of each day. Police Details and Contractors will work with residents to ensure their needs for access are addressed.

Police Details and signage will be in-place to assist motorists in reaching their destination.

Normal work hours are 7:00 AM to 4:00 PM Monday to Friday, weather permitting, unless otherwise noted.
