Sewer Construction Update

Chatham – C.C. Construction, Inc. will be continuing work for the Phase 1C-5 – Oyster Pond Sewer Extension (1C-5) and Dig It Construction LLC will be continuing work on the Phase 1E-2 – Stage Harbor Road Sewer Extension Project (1E-2) as outlined below.

Work for the week of September 29th – October 3rd:

1C-5:

- Continued site work is planned at the Oyster Pond Condominiums pumping station site (1233 Main Street).
- Monday 9/29: Continued site work is planned at the Independence Lane pumping station site.
- Continued site work/electrical work is planned at the Pond View West pumping station site.

1E-2:

- Thursday 10/2: Continued gas utility work is planned for the Harbormasters Garage/Pumping Station on Stage Harbor Road. ***Police detail(s) and signage will be in place in the vicinity of the work.***

Mill Pond Pumping Station (MPPS):

- Tentative - gas utility work is planned for the pumping station in the Mill Pond Road/Homestead Lane area. ***Police detail(s) and signage will be in place in the vicinity of the work.***

Two Week Look Ahead (10/6 – 10/10):

1C-5:

- Continued site work is planned at the Oyster Pond Condominiums pumping station site (1233 Main Street).

- Continued site/electrical work is planned at the Independence Lane and Pond View West pumping station sites.
- Tentative – sewer manhole work is planned, locations to be determined. ***Police detail and signage will be in place in the vicinity of the work.***

1E-2:

- Tentative – intermittent site work is planned at the pumping station site (Old Mill Boat Yard/Harbormasters Garage).

Mill Pond Pumping Station (MPPS):

- Tentative - gas utility work is planned for the pumping station in the Mill Pond Road/Homestead Lane area. ***Police detail(s) and signage will be in place in the vicinity of the work.***

Three Week Look Ahead (10/13 – 10/17):

1C-5:

- Continued site work is planned at the Oyster Pond Condominiums (OPC) pumping station site (1233 Main Street).
- Tentative – sewer manhole work is planned, locations to be determined. ***Police detail and signage will be in place in the vicinity of the work.***

1E-2:

- Tentative - intermittent site work is planned at the pumping station site (Old Mill Boat Yard/Harbormasters Garage).

Please note that this is a projected schedule and will be adjusted accordingly based on the Contractor’s actual progress and the weather.

Roads will be passable at the end of each day. Police Details and Contractors will work with residents to ensure their needs for access are addressed.

Police Details and signage will be in-place to assist motorists in reaching their destination.

Normal work hours are 7:00 AM to 4:00 PM Monday to Friday, weather permitting, unless otherwise noted.
